4. Arts groups must acknowledge NAC in all publicity materials only as follows: "This programme is endorsed by the National Arts Council Arts Education Programme (NAC-AEP) and is eligible for the 60% Tote Board Arts Grant subsidy."
5. For the purchase of tickets, the 60% subsidy is capped at \$20 per ticket.
6. The Post-Performance Report must be returned to NAC within 3 weeks of the completion of the performance(s).
7. NAC reserves the right to withdraw the endorsement for any programme following the receipt of negative feedback.

Failure to observe any of the abovementioned terms and conditions will result in the immediate withdrawal of NAC-AEP endorsement and will also influence the outcome of future applications.
